Processing Information

Collections are processed to a variety of levels, depending on the work necessary to make them usable, their perceived research value, the availability of staff, competing priorities, and whether or not further accruals are expected. The library attempts to provide a basic level of preservation and access for all collections as they are acquired, and does more extensive processing of higher priority collections as time and resources permit.

This collection received a basic level of processing, including rehousing and minimal organization. Various acquisitions associated with the collection have not been merged and organized as a whole. Each acquisition is described separately in the contents list below, titled according to month and year of acquisition.

Information included in the Description of Papers note and Collection Contents section is drawn from information supplied with the collection and from an initial survey of the contents. Folder titles

appearing in the contents list below are often based on those provided by the creator or previous custodian. Titles have not been verified against the contents of the folders in all cases. Otherwise, folder titles are supplied by staff during initial processing.

This finding aid may be updated periodically to account for new acquisitions to the collection and/or revisions in arrangement and description.

Edward J. Steichen

Edward J. Steichen (1879-1973) was a photographer and painter, as well as an art gallery and museum curator. Born in Luxembourg, he emigrated to the United States in 1881. Steichen was married three times. His first marriage, to Clara Smith Steichen (1875-1952), ended in divorce in 1922. His second marriage, to Dana Steichen, spanned from 1923 to her death in 1957. Steichen's third marriage, to Joanna T. Steichen, began in 1960 and lasted until his death.

Mary Steichen Calderone

Mary Steichen Calderone (1904-1998), daughter of photographer and artist Edward J. Steichen and Clara Smith Steichen, was a physician and a public health advocate for sex education. She had four daughters: Linda Martin and Nell Martin with her first husband, W. Lon Martin, and Francesca Calderone-Steichen and Maria S. Calderone with her second husband, Frank Calderone.

Charlotte "Kate" Rodina Steichen

Charlotte "Kate" Rodina Steichen (1908-1988), daughter of photographer and artist Edward J. Steichen and Clara Smith Steichen, was an administrative assistant from 1950 to 1960 to the editor in chief at the Doubleday Publishing Company, Kenneth Dale McCormick.

Lilian "Paula" Steichen

Lilian "Paula" Steichen (1883-1977) was the sister of photographer and artist Edward J. Steichen and wife of poet Carl Sandburg.

Scope and Contents

The Steichen family papers consist of photographs, correspondence, writings, exhibition materials, legal papers, genealogical materials, audiovisual materials, digital media, and other papers relating to Edward J.
