## Meryle Secrest

Meryle Secrest is a journalist and biographer. Born in Bath, England, she emigrated to Canada with her family, and eventually to the United States, where she worked for the *Washington Post* from 1964 to 1975. Secrest left the *Washington Post* to focus on writing books, and has published a number of biographies, including *Being Bernard Berenson* (Harmondsworth, 1980), which was a finalist for the 1980 Pulitzer Prize in Biography. In 2006 she received the National Humanities Medal.
