**SUMMARY:** Manuscript, primarily in Browne's hand, though numerous items are in other hands, of a collection of about 74 items, primarily on Parliamentary subjects and mostly dated 1641. Items include extracts from Parliamentary journals; speeches by James I and Charles I; discussions concerning Scotland; notes on the speeches of Edward, Earl of Conway and Sir John Coke; Parliamentary resolutions declaring ship money to be illegal; a protestation by the House of Commons vowing to uphold the Church of England against Jesuits and "Papists"; and numerous speeches concerning the trial of Thomas Wentworth, Earl of Strafford.
