Albert H. Wilbur

Albert Harper Wilbur, son of George Wilbur (1823-1858) and Sarah Ann Cook Wilbur (1816-1904), grew up in Belvidere, Illinois, with his brother, George Willis Wilbur (1851-1931). He moved west in 1875, first working in Nebraska for the Union Pacific Railroad Company. From there, he went to the Utah Territory and worked at the Western Union Telegraph Company as a telegraph operator, transferring to Carson City, Nevada, and then Reno, where he served as office manager until 1879. In 1879, Wilbur moved to Bodie, California, where he worked for G. L. Porter & Company, a lumber company, as bookkeeper and later as business manager. In 1880, he moved to Maricopa, Arizona Territory, and then to Lathrop, California, working for railroads as train master and agent. In 1883, he moved to Deming, New Mexico; San Francisco; then Suisun, California, where he stayed for 4 years, working as an agent for the Central Pacific Railroad. He married Laura Bofinger in Red Bluff, California, in 1890. After moving to Pomona, California, the couple had a daughter, Helen, born 1892 January 26. In 1896, Wilbur worked for the Southern Pacific Company in Toano, Nevada, eventually retiring to Los Angeles by 1923.

Correspondence and papers documenting the life of Albert H. Wilbur and members of the Wilbur family, 1849-1908. Includes autograph letters, signed, from Albert H. Wilbur to his brother, George W. Wilbur, and mother, Sarah Ann Cook Wilbur, in Illinois, 1875-1890, undated. Letters touch on Albert H. Wilbur's career and the health of his mother. There are also autograph letters, signed, from George W. Wilbur to Sarah Ann Cook Wilbur, and his wife, Ellen Rice Wilbur, 1870-1902, undated. Present is an autograph account, unsigned, of Albert H. Wilbur's trip to Southern California, written on verso of a map of California, 1876; an indenture, signed by George Wilbur and Sarah Ann Cook Wilbur, 1850; and manuscript business papers of George W. Wilbur, 1884-1890. There are also manuscript and typescript papers of the Parke & Lacy Machinery Company of San Francisco, California, 1883-1889; miscellaneous manuscript correspondence, 1869-1887; and empty envelopes, 1880-1897, undated.

Series I: Correspondence, 1870-1902, undated

Series I contains correspondence from Albert H. Wilbur to his brother, George W. Wilbur, and his mother, Sarah Ann Cook Wilbur, in Illinois. Letters touch on Alerbt H. Wilbur's career as a railroad employee and the health of his mother. There are also letters from George W. Wilbur to Sarah Ann Cook Wilbur, and his wife, Ellen Rice Wilbur. Additional letters are between "Bayard" and "Jo", from J. W. Cook to "Thomas", from Sarah Ann Cook Wilbur's sister to Sarah, and from A. H. Yale to an aunt. There is also a postcard to Susan W. Wilbur and unidentified correspondence. Accompanied by empty envelopes.

Series I is arranged chronologically.

Series II: Papers, 1850-1890, undated

English

Series II contains an autograph account, unsigned, of Albert H. Wilbur's trip to Southern California, recorded in 1876. There are also business papers of George W. Wilbur as well as those of the Parke & Lacy Machinery Company of San Francisco, California. Present are an indenture signed by George Wilbur and Sarah Ann Cook Wilbur, 1855, and a landlord agreement for A. H. Rice, 1855.

Series II is arranged chronologically.
