Processing Information

Collections are processed to a variety of levels, depending on the work necessary to make them usable, their perceived research value, the availability of staff, competing priorities, and whether or not further accruals are expected. The library attempts to provide a basic level of preservation and access for all collections [as they are acquired], and does more extensive processing of higher priority collections as time and resources permit.

This finding aid, created before the advent of computer-generated files, has been converted into a ASCII data file by means of scanning and Optical Character Recognition software. While attempts have been made to retain the complete information from the original document a number of format changes have been made to present the structure of this archive in accordance with current practice.

This finding aid may be updated periodically to account for new acquisitions to the collection and/or revisions in arrangement and description.

Henry Eld (1814-1850)

Henry Eld was born in New Haven, June 2, 1814, and died at sea on the U.S.S. Ohio, March 12, 1850. As Passed Midshipman he accompanied Lieutenant Charles Wilkes on the U.S. Exploring Expedition, 1838-1842, assigned first to the Peacock, and joined the Vincennes at Fiji. In 1841, Eld was ordered by Wilkes, commander of the expedition, to join the special overland expedition under Lieutenant George F. Emmons, from Vancouver, Wash., to San Francisco. As second in command, when the expedition separated at Sutter's, he led the overland party to San Francisco.

Scope and Contents

The Henry Eld Papers have been organized in two sections. The first section (WA MSS 161) consists of two journals kept by Henry Eld, Jr., U.S. Navy. The journals date from Eld's service in the Wilkes Expedition, 1838-42.

The first journal provides detailed information about an overland expedition from the Willamette Mission, south of Vancouver, to San Francisco, between September 6 and October 29, 1841. The journal is 126 pages long and is illustrated with forty-three manuscript maps (three of them double page, two of them folded). The two folded maps are entitled "Map of the Oregon Territory by U.S. Ex[ploring] Ex[pedition] and the Columbia River, reduced from a survey made by the U.S. Ex[ploring] Ex[pedition], 1841. J. H. Young & Sherman V. Smith, New York" and "Map of Upper California by U.S. Ex[ploring] Ex[pedition] and best authorities, 1841."

The second journal, which has been bound in the back of the journal of the Oregon and California overland expedition, is an incomplete thirty-page account of an expedition to survey Gray's Harbor and Shoalwater Bay, August 11 to September 7, 1841. The manuscript of the Gray's Harbor expedition is preceded by an extract from the Appendix of Charles Wilkes' *Narrative*, Volume IV, pages 533-36, including a letter from Wilkes ordering Eld to undertake this survey, with George Colvocoresses as his second in command, after which he was to proceed to join the ships in Baker's Bay.

Also included in the papers is a carbon copy of a typewritten transcript of Eld's diary from September 7 to October 29, 1841. The transcript, which was made by Alfred N. Meiss, is of a manuscript journal now in the possession of the New Haven Colony Historical Society. The journal is apparently a copy of the one in the Coe collection. It has some variations and insertions but includes additions which are in the

Coe manuscript and omits passages crossed out. The Historical Society also owns four other manuscript journals of Henry Eld, containing accounts of his experiences on the *John Adams* and the *Delaware*, on the Wilkes Expedition, and on the Antarctic cruise.

The journals are accompanied by three paper-covered sketchbooks containing forty-eight original drawings on forty-three loose leaves, each with guard sheet. The three sketchbooks are labeled "Henry Eld, Jr., U.S. Exploring Exped[ition] 1838-1842 No. 1 [No. 2 and No. 3]," and contain eleven sketches of scenes in Oregon and Washington, five of the Fiji Islands, three of other South Pacific Islands, one of California, and twenty-eight untitled. On the inside of the cover of Sketchbook No. 3 there is a pencil plan of San Francisco. The sketches are not reproduced in the Wilkes *Narrative* of the Expedition. A list of the sketches is appended below. In the list, the sketches are numbered consecutively by sketchbook. Some of the sketches were given titles by Eld. Those drawings which Eld failed to assign titles were given brief descriptive titles for purposes of the appended list.

The second section of the collection (WA MSS 162) consists of 100 letters, orders, and other papers of Lieutenant Henry Eld, Jr., dating from Eld's service in the United States Navy, 1845-51, as well as eleven letters written by or to Edward Eld, Henry Eld's brother, while the former was in California or Nebraska Territory, 1845-58.

The papers in the second section fall into five groups. The first group consists of material concerning Henry Eld, Jr.'s early years in the Navy, 1832-37. The papers in the second section relate to the U.S. Exploring Expedition, Captain Wilkes commanding, 1838-42. The material in the third group touches on the mutiny on the *Somers*, 1842-43. The fourth group contains correspondence of Henry Eld, Sr., with his son Henry Eld, Jr., during the Mexican War, 1846-49. The fifth group consists of letters to Henry Eld, Sr., after the death of his son (1850-51), family records and genealogy, as well as correspondence of Edward Eld with his family while in California and the Middle West (1849-58).

Henry Eld, Jr., kept copies of all letters connected with his service in the Navy, and, with few exceptions, it is these copies that have been preserved by the family. Accompanying the manuscripts there is a handmade, red morocco portfolio, with Arabic decorations. It is possible that Eld got this portfolio in Morocco when he served in the Mediterranean.
