SILAS REED (1807-1886)

Silas Reed was born in Ohio in 1807 and, after receiving a diploma from the Medical College of Ohio, lived in Cincinnati for several years. About 1838, Reed moved to Rock Island, Illinois, and in 1841 was appointed surveyor general of Illinois and Missouri by President William Henry Harrison. This appointment was not confirmed by the Senate, but after the presentation by Dr. Reed of letters and memorials to President John Tyler and the Senate, it was brought up again and approved. Dr. Reed served as surveyor general from March 17, 1841, to May 12, 1845, and continued to make his headquarters in St. Louis until 1870, when he was appointed the first surveyor general of Wyoming Territory by President Ulysses S. Grant. Due in part to political intrigue, he resigned in 1875 and devoted his remaining years to his mining interests in Utah and the promotion of the Dallas and Wichita Railroad Company in Texas. In 1876, he appeared before the Congressional Committee on Expenditures in the Interior Department in its investigation of surveys in the Territory of Wyoming. During the Civil War, Dr. Reed served as acting assistant surgeon in army hospitals in Tennessee and Missouri. He died in Utah on October 1 or 2, 1886.

Scope and Contents

The Silas Reed Papers (WA MSS 399) consist of diaries, correspondence, business and family papers, including maps and diagrams, written between 1833 and 1886. There are sixteen volumes in the collection.

<u>Series I, Diaries</u>, consists of twelve volumes, around 1,895 pages in all, and covering the dates January 1, 1872-August 29, 1874 and January 1, 1877-January 31, 1881. The diaries record Dr. Reed's trips to and from Boston and Washington and throughout the West. They include letters and telegrams received and sent, and brief references to business and family affairs.

The second and fourth series, <u>Miscellaneous Business Papers</u> and <u>Miscellaneous Legal Papers</u> include deeds (some of them forged), tax lists and receipts, and other documents relating to property in St. Louis and other parts of Missouri, as well as notes on mines and mining claims in Missouri and Utah, papers dealing with the Missouri Smelting and Mineral Lands Company, maps and diagrams, canceled drafts and notes, accounts, bills, and receipts.

The third series, <u>Correspondence</u>, includes Dr. Reed's letters to his wife, Henrieta Maria Rogers, written almost daily when they were separated, especially in 1872 and 1880-86, as well as letters to other members of the family. The letters to others are usually drafts or copies. Dr. Reed also obtained, by permission of the Senate, the original memorials and letters sent to Congress in his favor in 1841. The letters to his family give details of his business transactions, record the names of people he met, and provide news of political and local affairs, especially in Missouri and Wyoming. Reed's daughter, Clara James Reed, was the wife of Nathan Anthony, and the family correspondence includes letters to members of both the Reed and Anthony families from friends and relatives in the East as well as the letters of the Anthony family written between 1890 and 1893, after the death of Dr. Reed.

The fifth series consists of a <u>Scrapbook</u> of newspaper clippings in the collection. The book covers the dates 1837-86. The clippings are chiefly about Reed's appointment as surveyor general of Missouri and Illinois in 1841, the rejection of the appointment by the Senate and Reed's final confirmation, the investigation of his administration of the office, and the libel suit of the United States and James S. Conway (his successor as surveyor general) against Reed, editor of the St. Louis <u>Morning Post</u>, 1841-48.
