Sidney B. Kramer (1915-2014)

Sidney B. Kramer was an American publisher, literary agent and attorney who represented children's book author and illustrator Richard Scarry from 1965 to the 1980s. Born in New York, New York in 1915, Kramer graduated from New York University in 1936 and Brooklyn Law School in 1939. Kramer co-founded Bantam Books with Ian Ballantine, Betty Ballantine, and Walter B. Pitkin, Jr. in 1945, serving as its vice-president and director until 1967. He subsequently worked for Corgi Books and Cassell & Collier MacMillan in London, England and served as president of New American Library from 1967 to 1972.

Kramer established the literary agency MEWS Books Ltd., where he represented children's book authors such as Richard Scarry, Hardie Gramatky, Crockett Johnson, and Ruth Krauss. In addition to his publishing career, Kramer operated the Remarkable Bookshop in Westport, Connecticut with his wife Esther, where he also founded his own law firm. The couple was married in 1939 and had two children. Kramer died in Westport in 2014.

Content Description

The collection contains correspondence, business records, artwork, merchandise, audiovisual material, and other personal and professional papers relating to literary agent Sidney B. Kramer and his representation of author and illustrator Richard Scarry. Scarry's artwork includes original drawings, watercolors, and bluelines for his children's books. Merchandise includes toys, handkerchiefs, jigsaw puzzles, and party supplies featuring well-known Scarry characters such as Lowly Worm. Other business records pertain to Scarry's wife Patricia M. Scarry and son Huck Scarry, both of whom were also authors, as well as Kramer's other clients at MEWS Books Ltd., including Hardie Gramatky, Crockett Johnson, and Ruth Krauss. The collection also contains legal documents and personal files belonging to Kramer. Correspondents include publisher Ole Risom.

This series contains business records related to Sidney B. Kramer's literary agency MEWS Books Ltd. and its clients. Files pertaining to Richard Scarry consist of business correspondence, agreements, contracts, financial papers, royalties, tax records, publicity files, wills, notes, photographs, and other papers. The bulk of material documents Scarry's publishing and merchandising ventures, including foreign publishing contracts, licensing and copyright, and television rights. Notable correspondents include publisher Ole Risom. Present are page proofs for *What Do People Do All Day*?

Files pertaining to Huck Scarry consist of personal and professional correspondence, agreements, publishing contracts, and other business records. Included are watercolors and page proofs for his unpublished picture book "Cerise and Whiskers." The series also contains files related to his father Richard Scarry's estate.

Files pertaining to Patricia M. Scarry include personal letters and postcards exchanged with Kramer. Also present are publishing contracts for her children's books, and professional correspondence with other writers, illustrators, and publishers.

Files pertaining to Kramer's other literary clients document his representation of Hardie Gramatky, Crockett Johnson, Ruth Krauss, and other writers. Files include professional correspondence, typescript drafts, and publishing contracts.

Organized into four subseries: Richard Scarry Files, Huck Scarry Files, Patricia M. Scarry Files, and Other Client Files. Each subseries is arranged alphabetically by folder title, with oversize materials filed at the end of the sequence.
