Processing Information

Collections are processed to a variety of levels, depending on the work necessary to make them usable, their perceived research value, the availability of staff, competing priorities, and whether or not further accruals are expected. The library attempts to provide a basic level of preservation and access for all collections as they are acquired, and does more extensive processing of higher priority collections as time and resources permit.

This collection received a basic level of processing, including rehousing and minimal organization.

Information included in the Description of Papers note and Collection Contents section is drawn from information supplied with the collection and from an initial survey of the contents. Folder titles appearing in the contents list below are often based on those provided by the creator or previous custodian. Titles have not been verified against the contents of the folders in all cases. Otherwise, folder titles are supplied by staff during initial processing.

This finding aid may be updated periodically to account for new acquisitions to the collection or revisions in arrangement and description.

Biographical / Historical

The Landmarks Foundation was a non-profit organization founded in 1997 by Samuel Adams Green to conserve sacred sites and landscapes around the world. Their motto was "protecting sacred sites globally." The foundation directed funding and technical expertise to local groups that could not protect their cultural heritage sites without assistance. Originally based in New York City, the foundation relocated to Massachusetts after Green's death in 2011 and continued under the leadership of Haley Bain (formerly O'Neil) before closing.

Biographical / Historical

Samuel Adams Green (1940-2011) was an American art curator, socialite, preservationist, and founder of the Landmarks Foundation. He served as director of the Institute of Contemporary Art, Philadelphia, from 1964-1968, where he curated Andy Warhol's 1965 Retrospective. From 1968-1969 he worked as a Cultural Consultant for New York City's Office of Cultural Affairs, and from 1968-1972 served as Special Projects Director for the International Fund for Monuments (UNESCO) in New York. He also worked as a private art consultant, served as assistant to the British photographer Cecil Beaton, and was friends with Greta Garbo,

John Lennon, Yoko Ono, and other notable artists, cultural figures, and socialites. In 1996 Green launched the Cultural Heritage Foundation New York, which evolved into the Landmarks Foundation in 1997. He devoted the last decades of his life to preserving sacred cultural heritage sites and landscapes around the world.

Content Description

The Landmarks Foundation Records include correspondence, printed material, photographs, slides, research materials, computer files, and other materials relating to the organization's work to preserve sacred cultural heritage sites around the world. The foundation's work on sites in Turkey, Mexico, and Costa Rica and relationships with local individuals and organizations is particularly well documented in the project files with letters, faxes, photographs, and other papers. Green's collaboration with faculty and students at the University of Pennsylvania on different preservation projects is also well documented in correspondence and project proposals. The project files also provide insight into Green's approach to researching and scouting potential future projects for the organization. Administrative files include correspondence and other papers related to Green's efforts to raise funds, develop projects, and build relationships in support of the organization's work. The collection also includes a small amount of correspondence and other materials related to his work and life prior to the creation of the foundation.

Arrangement

Organized into three series: Series I. Project files, Series II. Administrative files, Series III. Computer media and audiovisual materials.

Collection Contents

Series I. Project files, 1968-2010

The Project files series consists of over nine boxes of materials that document with correspondence, photographs, reports, clippings, and other papers the organization's work in a number of countries across the globe. The files include documentation of both successful and unrealized projects, as well as Green's travel prior to the founding of the Landmarks Foundation.
