John Holker (1745-1822)

John Holker was an English-born French diplomat, merchant, and enslaver who moved to Pennsylvania during the American Revolutionary War. He was appointed French consul in Philadelphia and agent for the French Royal Marine in 1778, and in 1780, he became consul general for Pennsylvania, Delaware, New Jersey, and New York. From 1781 to 1784, he pursued private ventures with Robert Morris, the United States Superintendent of Finance and Agent of the Marine. After leaving his official post, Holker partnered with New York-based Parker, Duer & Co. to supply the Continental Army. He established a whiskey distillery

with William Duer in Poughkeepsie, New York, and invested with Morris, Duer, and Daniel Parker in the merchant ship *Empress of China*, an early American vessel engaged in the China trade. Other business partners included William Turnbull and Peter Marmié, with whom he built the Jacobs Creek Iron Works (also known as Alliance Iron Works) in western Pennsylvania in 1789. Married three times, Holker settled in Springsbury, Virginia, after the war.

Scope and Contents

The collection consists of correspondence, memoranda, accounts, and invoices relating to the activities of French diplomat and naval agent John Holker during the American Revolutionary War, as well as his private business ventures. Correspondents include Charles-François-Adrien Le Paulmier Annemours, François Barbé-Marbois, Henri-Léonard-Jean-Baptiste Bertin, Jacques-Donatien Le Ray de Chaumont, William Duer, Anne-César de La Luzerne, Peter Marmié, Gouverneur Morris, Robert Morris, Daniel Parker, Mark Pringle, Matthew Ridley, John Ross, William Smith, and William Turnbull. Materials concern supplying the French fleet and army, particularly troops commanded by Jean-Baptiste Donatien de Vimeur; Holker's dealings with Duer, Marmié, Robert Morris, Parker, and Turnbull, and investments in the merchant vessel *Empress of China*, Jacobs Creek Iron Works, and a whiskey distillery; and trade of American tobacco. Personal bills and invoices in the collection reference people enslaved by Holker. Also included is a card catalog of individual items in the collection, arranged in chronological order.

Collection Contents

Series I: Correspondence and Other Papers, 1777–1821

9.5 linear feet (10 boxes)

This series contains correspondence, memoranda, accounts, bills, invoices, sight drafts, orders, and other papers by or relating to John Holker, his role as agent to the French army and Navy during the American Revolution, and his other business activities. Correspondents include American financiers and agents William Duer, Peter Marmié, Daniel Parker, Mark Pringle, Matthew Ridley, John Ross, William Smith, and William Turnbull; Superintendent of Finance of the United States and Agent of the Marine Robert Morris and Assistant Superintendent of Finance Gouverneur Morris; and Holker's father, French businessman Jean Holker. Also present are correspondence and papers related to French merchants Fizeaux & Cie., Ferdinand Grand, Le Couteulx & Cie., Reculès de Basmarein & Raimbaux, Barthélémy Terrasson, and Roulhac & Cie.; and French diplomats and military officers such as Charles-François-Adrien Le Paulmier Annemours, François Barbé-Marbois, Henri-Léonard-Jean-Baptiste Bertin, Jacques-Donatien Le Ray de Chaumont, Anne-César de La Luzerne, and Jean Baptiste Charles Henri Hector. Materials concern supplying horses, food, and equipment to French troops commanded by Jean-Baptiste Donatien de Vimeur, comte de Rochambeau, in Newport, Rhode Island; shipping interests of the Meulan d'Ablois family; trade of tobacco and indigo; Holker's legal disputes with Duer, Ross, and Smith; and his investments in Empress of China and Jacobs Creek Iron Works. The series also contains a small amount of personal papers documenting Holker's enslavement of at least three people, divorce from his wife Elisabeth, and the settlement of his father's estate.
