**SUMMARY:** The Charles Hanbury-Williams Papers primarily contain correspondence

and other materials that document his diplomatic activities in the political, social, and cultural life at the royal courts in Berlin, Dresden, Saint Petersburg, and Warsaw in the 1740s and 1750s, as well as those of his predecessor envoys George Woodward (1697-1735) in Warsaw and Melchior Guy Dickens (1695-1775) in Saint Petersburg. Hanbury-Williams's domestic, personal, literary, and family papers are present in smaller quantity, but those files encompass his friends and family in London and Monmouthshire, Wales, and his parliamentary constituents and friends in Herefordshire, England. Significantly represented in the files are Hanbury-Williams's colleagues Henry Harris, Thomas Winnington, and Henry Fox, Baron Holland; his Hanbury brothers; his wife Lady Frances Coningsby Hanbury-Williams and her father Lord Thomas Coningsby; and his two daughters Lady Frances ("Fanny") Hanbury-Williams Essex and Charlotte Hanbury-Williams

Walsingham.

## **Custodial History**

Tone Sundt Urstad, in her unpublished 1987 University of Cambridge dissertation on Hanbury-Williams, describes the library's Hanbury-Williams collection as comprising between six and seven thousand items, and relates their provenance as originating from "two different sources, the major part from the Hanbury Williams family at Coldbrook [in Wales], and about four hundred letters from Lord Essex at Cassiobury [Watford, England]." The majority of the papers descended to Hanbury-Williams's greatnephew Ferdinand Hanbury-Williams (1799-1887) when he inherited Coldbrook; he sold them in 1841 to Sir Thomas Phillipps (1792-1872), a collector of books and manuscripts.

Separately, George Capel-Coningsby, 5th Earl of Essex (1757–1839) had given the family letters to the firm of Jeffery and King to have them bound, and then neglected to retrieve them. The firm went into bankruptcy and sold the letters to the bookseller James Bohn, who sold them to Phillipps in 1840.

The items in the library's Charles Hanbury-Williams Papers appear in Thomas Phillipps's *Catalogus librorum manuscriptorum in bibliotheca* ([Middle Hill]: Impressus typis Medio-Montanis mense maio, 1837 [-1871]), in two blocks: the "Sir Charles Hanbury Williams' MSS" on pages 179-180, bearing Phillipps numbers 10876 through 10944 (minus "bundles" 10921-10923 and "packets" 10941-10943) and the "Supplement to Sir Ch. H. William's MSS" on pages 193-194 and 201, bearing Phillipps numbers 11374 through 11410 and 11660. The latter block cites Hanbury-Williams's own volume numbers in their entries, which the first block does not. Also present in the library's Hanbury-Williams Papers are Phillipps volumes 23965 and 26018, which do not appear in his printed catalogue.

Thomas Phillipps's collection was dispersed in a series of sales presided over by his grandson Thomas Fitzroy Fenwick (1856-1938). When he died, the residue passed to his nephew Alan George Fenwick who, in 1945, sold the remaining material to the London antiquarian booksellers Lionel and Philip Robinson. Wilmarth S. Lewis purchased the papers described in this collection guide from William H. Robinson Ltd. in June 1949. One additional volume (Hanbury-Williams number 26, Phillipps number 10886, in Box 51) was purchased from the New York dealer H. P. Kraus in 1981.

With the 1949 purchase came an inventory of the Hanbury-Williams papers made by Thomas FitzRoy Phillipps Fenwick; this manuscript has been cataloged separately as LWL MSS 7a and is not included in this collection guide.

## **Processing Information**

Upon arrival in Wilmarth Lewis's collection, the ninety-four volumes of papers were shelved by their Hanbury-Williams volume numbers, with library staff creating access inventories by both Hanbury-Williams and Phillipps volume numbers. The volumes ranged in size from octavo to folio. Most of the diplomatic material was either created in bound volumes (such as the chronological copies of his outgoing letters) or were bound later by theme (all incoming letters from a secretary of state or a cohort of British envoys). In general, the domestic and family correspondence appears to have been gathered randomly and bound somewhat by sheet size or approximate date. Many of the volumes held papers that extended beyond their covers, so that material was being damaged both in use and storage. In the late 1990s the library decided to disbind nearly half of the collection—forty-three of the ninety-four volumes—and to house some of the loose papers in archival folders and boxes and some laying loose within their covers in phase boxes. The Hanbury-Williams volume number and page or leaf ("fol.") number was written on each piece of loose paper.

Though a rearrangement of the papers was proposed in 1997, the papers remained in their mixed-housing format in order by Hanbury-Williams volume and page numbers until 2023, when the collection was reorganized into an intellectual arrangement of four distinct series that provide a clearer understanding of Hanbury-Williams's diplomatic career and, as important, that separate and highlight his domestic relationships and activities in England and Wales. As an example, the correspondence between Hanbury-Williams and his daughter Charlotte formerly appeared throughout seventeen different albums (his volumes number 31, 52, 54, 58-61, 66-67, 71-72, 75-79, and 82-83) and it is now held in four folders in Box 44.

For material that remains bound together, the Hanbury-Williams and Phillipps numbers are given in each volume's headnote so if that level of access is required, this guide can be keyword searched to locate a particular volume. The empty cases (covers and spines) from disbound volumes form Series V in the papers, and a list of the volumes with both Hanbury-Williams and Phillipps numbers can be seen in that section of this guide. Many of the volumes also have a third number that had been written in ink on the front cover label; it is not known who assigned those numbers or when, but they are also mentioned in the headnote as tertiary numbers.

Another decision made in 2023 was to identify and validate both foreign and domestic names in the papers. The author signatures and names docketed by Hanbury-Williams or his secretary were checked first in the Library of Congress's Name Authority File, and if not found there, in sources such as the *Dictionary of National Biography*. Refinements and several new identifications were possible as so many online sources—including digitized books and newspapers, and databases such as Biografisch Portaal van Nederland (http://www.biografischportaal.nl/), Deutsche Biographie (https://www.deutschebiographie.de/home), and Die Sächsische Biografie (https://saebi.isgv.de/)—were not available to the Walpole editors in the 1950s. When possible, names were upgraded to Library of Congress standards, and others were newly identified: Russian diplomat "Count Bestoucheff" has an authorized name of Aleksei? Petrovich Bestuzhev-Ri?u?min, and "Baron Hoensleben" was found to be the Hanoverian envoy Johann Friedrich Karl Alvensleben. Some people, such as D. H. B. Swansbel (per Walpole editors, and alternately spelled Schwanbel by Hanbury-Williams), were not conclusively identified.

## **Related Materials**

The Reference Library at the Newport Central Library on John Frost Square in Newport, Wales, holds twenty-five volumes of Sir Charles Hanbury-Williams's papers. Among the records are volumes of dispatches from successive secretaries of state (1752–1757), two volumes of letters and instructions from the secretary of state (September 1754 to March 1755), a volume of correspondence (1756–1757) between Andrew Mitchell in Berlin and Hanbury-Williams, a diary kept by Hanbury-Williams during his residence at Berlin (July 1750 to March 1751), and some of Hanbury-Williams's writings on foreign affairs. Also there are volumes of correspondence between the secretary of state and Thomas Robinson, the British envoy at Dresden (1732-1734), some literary papers, and loose correspondence with Robert Walpole, Henry Pelham, Henry Fox, Lord Chesterfield, Horace Walpole, and various ministers and friends of Hanbury Williams. The materials were presented to the Newport Central Library by Ruth Hanbury Tenison, daughter of John Capel Hanbury of Pontypool Park, on April 15, 1924.

# Separated Materials

Four letters from Horace Walpole—three to Charles Hanbury-Williams and one to his daughter Frances ("Fanny") Hanbury-Williams Capel, Lady Essex—were removed from this collection and filed into the library's Horace Walpole Collection (LWL MSS 1). The letters to Hanbury-Williams were formerly in his volume 52 (Phillipps 10902), and to Lady Essex in volume 64 (Phillipps 10911). They can be located in the LWL MSS 1 finding guide as well as in Archives at Yale and in the print and online versions of *Yale Edition of Horace Walpole's Correspondence*.

# **Hanbury-Williams Card Indexes**

An additional way of accessing content in the Charles Hanbury-Williams Papers are the three sets of paper card and slip files in the library's reading room. These files were created in the 1950s by the editors of the *Yale Edition of Horace Walpole's Correspondence* (working in room 331B in Yale's Sterling Memorial Library), once Lewis had the collection sent to campus after it arrived in Connecticut in 1949. The editorial team read every letter and document present—including those in foreign languages—and indexed each item by date, correspondent, and subject. The three groupings are: 1) six drawers of chronological cards filed by undated material, then 1584-1808. with each card giving a precis of the content of the item; 2) two drawers of typed paper slips with names of correspondents (both author and recipient); and 3) four drawers of typed "subject" slips that index the names of people mentioned within letters and documents and give the numbers of the Hanbury-Williams (two digits) and Phillipps (five digits) volume and the page ("fol.") number in that volume. Those cards are for names only; no topics, events, or places were indexed. None of the card or slip files described above reveal biographical clues to occupations, relationships, or other personal or political contexts for the people mentioned; they are simply names with volume and page numbers.

However, as an example of their value, the folder for Friedrich Benedict Oertel (Box 19, folder 34) holds eight letters the Prussian magistrate sent to Hanbury-Williams in the months prior to his 1748 death, and three that his family members sent soon afterward. The correspondent slips record all eleven letters, but the subject slips reveal that Oertel was mentioned in nine other letters Hanbury-Williams received from his diplomatic correspondents Arnett, Fritsch, Gervinus, and Perrone di San Martino, as well as in three letters from the British Grand Tour tutor Walter Harte.

When using the correspondent and subject indexes, it is important to note that the Walpole editors at that time performed no authority or standardization work on names, which were transcribed just

as they appear in a signature or within a letter or document; as a consequence, multiple slips were created for some individuals reflecting each of the variant spellings of their names. Equally important, many of those names will not match with those in this collection guide, which employed the Library of Congress's Name Authority File and other standard sources for constructing correspondents' names (see the Processing Information section of this guide). For instance, letters from Lord and Viscount Stormont are filed under Mansfield, David Murray, Earl of, and those from Hanbury-Williams's secretary Stanislas Poniatowski are under his authorized name of Stanis?aw II August, King of Poland.

To locate a letter or document found in one of the library's card sets, where the card will show a citation such as "50-10918 fol. 22-23" (which is Hanbury-Williams volume 50-10918 Phillipps volume, pages 22-23) keyword search the PDF version of this collection guide for the Phillipps volume number. If the item remains in a bound volume, request that box. If not, search for the person's name to find an entry with dates that match or encompass the item sought, and request that folder and box.

These informative and extensive sets of approximately 14,000 cards and slips do not provide a complete index to the papers but, nevertheless, they are a useful resource—the "subject" slips in particular. Again, these paper-based files can only be accessed in the library's reading room. They are not digitized and the information on them was not incorporated in this collection guide.

## Charles Hanbury-Williams, 1708-1759

Sir Charles Hanbury-Williams (1708-1759) was a Welsh politician, diplomat, and poet. He was born in London, the fourth of seven sons born to John Hanbury (1664-1734) of Pontypool, Wales, and his second wife Bridget Ayscough (-1741). The Hanbury family made their fortune from Welsh iron mines. In 1729 Charles Hanbury assumed a second surname of Williams, from Charles Williams (1634-1720) who had left a fortune to John Hanbury which was passed on to his son Charles. After attending Eton College and taking a grand tour, Hanbury-Williams returned to London and in 1732 married Lady Frances Coningsby (1708-1781), a daughter of Lord Thomas Coningsby (1657-1729) of Hampton Court in Herefordshire. Upon Coningsby's death she inherited half of his estate, and the remainder in 1761 when her older and only sibling Margaret Coningsby Newton died. Hanbury-Williams and his wife had two children: Frances ("Fanny") (1735-1759), who married William Anne Holles Capel (1732-1799), 4th Earl Essex; and Charlotte (1738-1790), who married Robert Boyle Walsingham (1736-1780). The Hanbury-Williams marriage foundered on the issues of his infidelity and was ended by September 1742 over the advanced case of syphilis he had given his wife.

Hanbury-Williams held a number of posts during his lifetime, both by election and appointment. He was elected to Parliament for Monmouthshire (1735-1747), and 1737 was appointed Paymaster of Marines (resigned 1746). In 1741 he was appointed Lord Lieutenant of Herefordshire (resigned 1745), and in 1754 again elected to Parliament, but for Leominster in Herefordshire. He became a Knight of the Bath in 1744. A popular society figure in London, Hanbury-Williams joined the Society of Dilettanti in 1736 and was elected to White's Club in 1743.

Most remembered for his diplomatic appointments, Hanbury-Williams served as minister to the Electorate of Saxony at Dresden (1747-1750 and 1754-1755) and the Kingdom of Prussia at Berlin (1750-1753). In 1755 he took his final post as envoy to the Russian Empire at Saint Petersburg, before returning to England in 1758. He spent his last two years plagued and incapacitated by physical and mental illnesses, likely the effects of tertiary syphilis, and died in London on November 2, 1759. Charles Hanbury-Williams's remains were interred in the north choir aisle of Westminster Abbey near those of his patron Charles Williams; there is no monument for him.

A concise biography of Hanbury-Williams by Mary Margaret Stewart (2008) appears in the *Dictionary of National Biography*; the standard biography has been *The Life of Sir Charles Hanbury-Williams, Poet, Wit and Diplomatist*, by the Earl of Ilchester and Mrs. Langford-Brooke (London: T. Butterworth Ltd., 1928). A resource for Hanbury family genealogy is Richard Hanbury Tenison's *The Hanburys of Monmouthshire* (1995).

# **Scope and Contents**

The Charles Hanbury-Williams Papers contains correspondence and other materials that document his activities in the political, social, and cultural life at the royal courts in Berlin, Dresden, Saint Petersburg, and Warsaw in the 1740s and 1750s, as well as those of his predecessor envoys George Woodward (1697-1735) and Melchior Guy Dickens (1695-1775). Hanbury-Williams's political, personal, literary, and family papers are present in smaller quantity, but those files encompass his friends and family in London and Monmouthshire, Wales, and his parliamentary constituents and friends in Herefordshire, England. Significantly represented in the correspondence files are Hanbury-Williams's colleagues Henry Harris, Thomas Winnington, and Henry Fox, Baron Holland; his Hanbury brothers; his wife Lady Frances Coningsby Hanbury-Williams and her father Lord Thomas Coningsby; and his two daughters Frances ("Fanny") Hanbury-Williams Capel, Lady Essex, and Charlotte Hanbury-Williams Walsingham.

The eight linear feet of material in Series I, Diplomatic Papers, comprises the greatest part of the collection; only eight of the thirty-five boxes in the series contain material that was removed from bound volumes, so this series is the most intact from the arrangement created by Hanbury-Williams himself. Series II, Domestic and Political Papers, is two feet of correspondence with his constituents, friends, and colleagues in Southern Wales, Herefordshire, Bath, and London; all the material here was removed from bound volumes and filed in boxes and folders for easier access to letters from specific people. Series III, Personal Papers, also measures two linear feet and holds important correspondence between Hanbury-Williams, his wife, and two daughters, as well as with his brothers, and between his daughters and their uncles; these letters are personal and reveal the landscape of Hanbury-Williams's life and the tragedy of his later years. Also here are literary works, primarily poems, by Hanbury-Williams and others. A few estate papers close out the series. Series IV., measuring under two linear feet, Is the smallest part of the papers, and holds third-party correspondence between family members and their friends and colleagues. Series V. contains only the empty cases from the volumes of correspondence that has been disbound.

## **Collection Contents**

# Series I: Diplomatic Papers, 1720-1758

8.13 linear feet (35 boxes)

The series contains the bulk of Charles Hanbury-Williams's papers, and the material not only spans his entire diplomatic career, but takes in papers of two of the ministers that held posts in Warsaw and Saint Petersburg before him. Hanbury-Williams received his first appointment as minister to the Electorate of Saxony in December 1746, and for a decade beginning in April 1747, he moved through a series of appointments in Dresden, Berlin, Warsaw, and Saint Petersburg at the courts of Saxony, Prussia, Poland, and Russia, before returning to England in February 1758. For that reason, his cohort of correspondents—British and foreign—remained fairly constant even though his location would change.

Much of the material in Series I is held in bound volumes. The Correspondence subseries contains both incoming and outgoing (in fair copy) letters discussing a wide variety of diplomatic negotiations, as well as reports on local events interspersed with intelligence and court gossip. Also here is Hanbury-Williams's correspondence with the vendors and bankers that moved merchandise meant for him and to others as court gifts. The Documents subseries contains correspondence, pro memoria, copies of treaties, and various historical documents meant to inform Hanbury-Williams about past negotiations. Also present here is a volume related to the disposition of the Ostrog region which was was of great interest to the Poniatowski family, and Hanbury-Williams's support lead to a fracture in his relationship with Count Brühl. The subseries Papers of Prior Envoys holds bound volumes of diplomatic records left by the British ministers George Woodward and Melchior Guy Dickens who preceded Hanbury-Williams in Dresden, Warsaw, and Saint Petersburg.

The contents of the bound volumes are described overall in headnotes; in many cases the items enclosed have been either listed by page number or indexed by author or recipient. His outgoing correspondence was generally recorded in chronological order but the incoming letters were grouped in various ways before being bound. For ease of access to letters from particular envoys, their names were listed in alphabetical order and the relevant page numbers in the volume were cited. Titles of diplomatic docouments were transcribed as they were written; abbreviations and spellings were preserved and diacritics were not added.

Series I is organized into three subseries: Correspondence, Documents, and Papers of Prior Envoys.

Correspondence

### Letters and reports, 1745-1749

1745 April 23-1749 July 14

The volume holds 266 pages of letters primarily from Philip Dormer Stanhope, Earl of Chesterfield, and Thomas Pelham-Holles, Duke of Newcastle, writing from Whitehall in London. Also present are letters of instruction from George II appointing Hanbury-Williams Envoy Extraordinary at the Court of the King of Poland in 1747 (pages 13-24), his letter of revocation in 1749 for reassignment to the Court of the King of Prussia (pages 199-202), and his instructions from King George II for travel to Anspach to invest Charles William Frederick, the Margrave of Anspach,

with the Ensigns of the Order of the Garter (pages 263-265). The letters in the volume were bound nearly in chronological order.

Other items in the volume are a copy of a letter written in 1715 to George Townshend from members of the Board of Trade (pages 1-8) and a copy of Lord Harrington's letter to all ministers abroad regarding court couriers, with a list of charges for their trips between Whitehall or Hanover and foreign cities (pages 9-12). Near the end of the volume (pages 243-262), is a "Paper delivered by Count Fleming," in which Saxon minister Karl Georg Friedrich Flemming mentions the June 1747 "double wedding" of Bavarian Elector Maximilian Joseph and his sister Princess Maria Antonia to the Electoral Prince Friedrich Christian of Saxony and his sister Princess Maria Anna; the marriage united the ruling families of Bavaria and Saxony.

The volume is untitled; it is in a stiff-board binding covered in brown paper with a blue linen spine and has no label on the front cover. The Hanbury-Williams volume number is 34; the Phillipps number is 10906.

Letters and reports, 1750-1751

The volume holds 480 pages of letters from Thomas Pelham-Holles, Duke of Newcastle, bound in chronological order. At the front of the book are two letters of instruction from King George II appointing Hanbury-Williams as Envoy Extraordinary and Plenipotentiary to the court of the King of Prussia in Berlin; a third letter of instruction for his appointment to the Court of the King of Poland (January 22, 1751) appears at page 203.

"Instructions and Letters From the Secretary of State Received at Berlin and Dresden" is in a stiff-board binding covered in marbled paper, with a cut paper label on the front cover and printed CH-W and Phillipps number labels on the spine. The Hanbury-Williams volume number is 13; the Phillipps number is 10917, with a tertiary number of 43.

The volume holds 368 pages of copies of letters from Thomas Pelham-Holles, Duke of Newcastle and Secretary of State, to Hanbury-Williams; the material is in English, Latin, and French, and replicates some of the material that appears in volume 13. Volume 16 opens with letters from King George II and from Newcastle to the King and Queen of Prussia introducing Hanbury-Williams, and instructions from the King to Hanbury-Williams, appointing him as Envoy Extraordinary and Plenipotentiary to the Court of Prussia in June 1750. Copies of letters from Newcastle to Hanbury-Williams begin on page 19. In addition to transcriptions of those letters, there are also letters Newcastle sent to other British foreign ministers, as well as pro memoria and various diplomatic documents. The volume ends with Hanbury-Williams's instructions from the King appointing him to the Court of the King of Poland in Warsaw, dated June 20, 1754.

Some of the material concerns negotiations with the Duc de Mirepoix and Thomas Robinson. It is in English and French, and dates between January and April 1755, with some papers referencing earlier events.

The volume holds 356 pages of fair copies of Hanbury-Williams's letters to the secretaries of state for the Northern Division, Philip Stanhope, Earl of Chesterfield (June 2, 1747, through mid-March 1748) and Thomas Pelham-Holles, Duke of Newcastle (thereafter) sent from his post in Dresden and while on a visit to Leipzig (May 1749); some letters are addressed to under-secretaries William Chetwynd and Andrew Stone.

The first items in the book are copies of letters from King George II to the King and Queen of Poland in February 1747, and a copy of a post from the East India Company about the plunder of Fort St. George in Madras; letters to the secretaries begin on page 5. Also present are letters to Thomas Robinson, Earl of Grantham and ambassador to Vienna (June 9 through July 9, 1747) and to John Carmichael, Earl of Hyndford and ambassador to Russia (October 1748). The last letter in the volume, written to Newcastle on August 13, 1749, fills eight pages and was sent as Hanbury-Williams's final post from Dresden.

The volume holds 692 pages of letters and reports sent primarily to Secretary of State Thomas Pelham-Holles, Duke of Newcastle, with reports, documents, and copies of letters sent as enclosures between Hanbury-Williams, Newcastle, and other diplomats. Hanbury-Williams titled this volume "Papers of Consequence," but he did not otherwise impose a discernable order to the materials, in both French and English, that he had accumulated between 1748 and 1751, as he moved between Dresden, Berlin, and Dresden again.

The volume opens with a significant set of diplomatic reports meant for the King's eyes. The other reports vary in topic and substance with some just recording conversations or presentations. Among the reports is one titled "Portrait du Roi de P.," in which the author, presumably Hanbury-Williams, states that the King of Poland has the most beautiful eyes in the world.

### Foreign Correspondents

The letters in this section came from various foreign diplomats, government officials, counts, and their wives, as well as authors and other cultural figures. An attempt was made to identify the correspondents; brief biographical statements are included for those who could be found, and locations are listed for the elusive. The material is primarily in French.

The letters cover political, social, and business topics. The greatest number are from three diplomats: Louis de Marteville, the Dutch ambassador in

Stockholm; Saxon minister Gerlach Adolph Freiherr von Münchhausen; and Stanisław II August, the King of Poland, during the years he served as a secretary to Hanbury-Williams (under his birth name Stanisław August Poniatowski). Also present are letters from Poniatowski's brother and both of his parents. At the other end of the spectrum, Nicholas Gwynne and Daniel Von Heck both wrote from Leyden regarding the Leyden Post Office's expenses in forwarding Hanbury-Williams's dispatches.

Notable cultural figures include the painter Anton Raphael Mengs and the engraver and art historian Jakob von Staehlin in Saint Petersburg; Staehlin wrote to announce the arrival of French sculptor Nicolas-François Gillet (1709-1791) and painter Louis-Joseph Le Lorrain (1715-1759) at the Imperial Academy. There are letters from two French authors, François-Thomas-Marie de Baculard d'Arnaud and Voltaire, and the Swiss author Jean Baptiste Tollot. Musicians are represented by letters from the Florentine contralto Vittoria Tesi Tramontini writing from Vienna, and the Italian-Austrian soprano Regina Mingotti who was then performing in Madrid, plus one from the Italian contralto Pasqualino Bruscolini performing in Warsaw.

Material filed here came from multiple bound volumes that had been disbound in the mid-1990s, including Hanbury-Williams volumes 9, 30, 31, 32, 49, 50, 51, 54, 55, 62, 63, 64, 74, and 95. The letters were foldered alphabetically by author in 2023, with the unidentified correspondents filed at the end.

Organized under three headings: Diplomats and Colleagues, Unidentified Correspondents, and Business Associates.

They range in quantity from multiple communications from the Scottish merchant and banker Archibald Gibsone in Danzig and Frederic Chrestien Gervinus in Dresden, to a just few receipts from the French wine merchant Victor Cliquot, Dresden confiturier Jean Godefroi Gerlach, goldsmiths Jean Jaques Pallard and George Wickes, and an unidentified Dresden tailor. The Wickes invoice, dated 1747, describes numerous items of engraved silver flatware and serving pieces as well as the "iron bound cases with bags and locks" for shipping to Dresden.

Of interest is John Hanbury, a member of the Right Worshipful Society of Merchant Adventurers in Hamburg, and vice-consul of the English factory there; though likely a relative, it is unclear where he falls on the family tree. Aside from engaging in a decade of forwarding freight for the diplomat, he writes on April 2, 1756, with a letter of introduction to Michael Stewart, British equilibrist who had performed in Hamburg and was on his way to Saint Petersburg and Moscow.

The George Woodward Papers document England's diplomatic efforts in Warsaw and Dresden a decade before Charles Hanbury-Williams arrived in 1747. #### Correspondence

The Correspondence subseries contains both incoming letters and copies of Woodward's outgoing letters. Two volumes hold incoming letters, one has incoming and outgoing, and the fourth has only outgoing. The term "foul draughts" in the volume titles refers to the alterations and corrections seen on the drafts; occasionally, Woodward (or his secretary) has noted a portion of the letter that had been sent out in cypher.

The volume contains 558 pages of diplomatic appointment papers and letters from three secretaries of state: Charles Townshend, Lord Townshend; William Stanhope, Earl of Harrington; and Thomas Pelham-Holles, Duke of Newcastle. Their letters inform him of the King's movements outside of England, of deaths in the royal family (for advising the King of Poland and for mourning rituals to be observed), and of opinions and further instructions from the King. Many letters have sections written in cypher, and some have enclosures such as copies of letters the King had sent to Poland and speeches he gave in Parliament. In their letters, Townshend and Newcastle also comment on or respond to the dispatches Woodward had sent in to Windsor and Whitehall. The material was bound in a chronological order; the pages are numbered.

Two smaller sets of records, Business Associates and Paymaster of Marines Records, follow the first two subseries and hold correspondence and papers that document the merchants he dealt with and an important political position he held for a decade.

Some of the letters in Series II could also be from colleagues he interacted with—or who wrote to him—while he served in Europe, such as Elizabeth Bosanquet in Hamburg or the historian/author John Campbell in London, but they are filed here because their authors were not involved in court affairs or negotiations. The correspondence in Series I constitutes Hanbury-Williams's official diplomatic record.

The last subseries, Paymaster of Marines Records, holds correspondence and documents related to a position he held from November 1737 through December 1746.

As Charles Hanbury-Williams's health began to fail in 1758, his steward and secretary James Price began to handle his correspondence and business affairs and did so through his death and afterward. A decision was made in 2023 to interfile letters to and from Price as if they were to and from Hanbury-Williams. None of the matters covered concern Price's personal life or business; the content within the letters is expressly for and about Hanbury-Williams.

The letters in this series came from multiple bound volumes that had been disbound in the mid-1990s, including Hanbury-Williams volumes 9, 30, 31, 32, 49, 50, 51, 54, 55, 62, 63, 64, 74, 75, 83, and 95. In 2023 the material was foldered alphabetically by author, with unidentified correspondents filed at the end.

Series II is organized into four subseries: English Friends and Colleagues, Welsh and Herefordshire Friends and Colleagues, Business Associates, and Paymaster of Marines Records.

#### **English Friends and Colleagues**

1731-1758

The subseries holds letters from Hanbury-Williams's contacts ranging from his Parliament peers to friends from London and colleagues touring Europe. Many of the writers ask for favors such as an order for porcelain tableware by Sir Henry Oxenden, or a customs appointment in Bristol by John Giles, or Richard Gaven looking to sell a Raphael painting in Dresden. Others offered news and gossip as did John Calcraft, whose twenty letters carry details of political activities and, on January 3, 1755, word of the recent deaths of Lords Albermarle and Levenson-Gower, plus the non-public details of the death by suicide of Henry Bromley, Baron Montfort. John Poulett, Lord of the Bedchamber, sent detailed bulletins during the days leading to the death of Queen Caroline on November 20, 1737. Some letters are more personal as those of the artist Henry Robert Morland, who cleaned some of Hanbury-Williams's paintings and negotiated to purchase them.

The Grand Tour features in the subseries: there are more than thirty letters from Thomas Steavens with lengthy reports from Vienna, Venice, Berlin, and other cities, during his multi-year travels. Two folders of letters from the poet Walter Harte cover his years of employment as tutor to the son of Philip Dormer Stanhope, Lord Chesterfield, on his grand tour; also present are letters from his student Stanhope. Hanbury-Williams offered support to other young men studying abroad, including Edward Craggs Eliot (also tutored by Harte), Richard Sutton in Gottingen, and George Yonge in Leipzig.

Hanbury-Williams's social intimates are well represented by two folders of letters each from Henry Harris and Thomas Winnington, and eight folders from Henry Fox, Baron Holland.

The writers in this subseries predominately were British citizens writing from the United Kingdom, but some wrote while traveling abroad. While the content of their letters—such as those of Richard Combe—may appear quasi-diplomatic due to foreign contacts and reports of events mentioned, the men were not known to be operating as agents of any government.

This subseries contains letters from constitutents and friends in Herefordshire and Monmouthshire—Leominster in particular—as well as a few political documents related to Hanbury-Williams's parliamentary career. He had won the seat for Monmouthshire long held by his father when his father died in 1734, was reelected in 1741, and held it until his brother Capel won it in 1747. Also in 1741, through the influence of his wife's family, he was appointed lord lieutenant of Herefordshire, and in 1744 elected the high steward of the corporation of Leominster for life. In addition, in October 1744, Hanbury-Williams was installed as

Unlike correspondence in other parts of the collection, many letters here were addressed to Hanbury-Williams as "Knight of the Bath," "Member of Parliament," or both, and sent to him at Coldbrook [or Coldbrooke], Whitehall, or at "his Lodgings at Bath." Writers from Bath, Monmouth, Leominster, and the region ask for political or financial assistance, and favors such as various military and other appointments for friends and family. In many instances Lord John Bateman (1721-1802) of Shobdon Court in Leominster is mentioned; he assumed the post

of Lord Lieutenant of Herefordshire in 1747. Also referenced in letters is a visit Hanbury-Williams made to Ruperra Castle, a Morgan family property in Caerphilly, Wales.

One of the major correspondents here is Hanbury-Williams's close friend Rev. James Birt, whose more than forty letters cover local news of friends, the Hanbury family, local and federal politics, and literature. The collection also has thirteen of Birt's replies, which are filed after his letters to Hanbury-Williams. Other notable (for volume) correspondents are William Fortune, Rev. Benjamin Lewis, and Joseph Pember; also in that group is Thomas Williams, the property manager at Coldbrook.

At the end of the subseries is a poll book from Leominster recording the votes in 1747, and a set of reports on actions taken in Parliament between 1747 and 1752, with three political documents.

In late November 1737 Hanbury-Williams was appointed paymaster of Marines. In 1745 a House of Commons committee began an investigation of the unit's procedures, and though Hanbury-Williams was never implicated, the months-long inquiry distressed him greatly. He resigned the position in December 1746.

# Series III: Personal Papers, 1717-1774

2.1 linear feet (5 boxes)

The series contains a range of papers that stand separate from Charles Hanbury-Williams's diplomatic, government, and political careers: here they center on his family, his literary interests, and matters pertaining to his estate. The earliest item in the series is a poem from 1717 and the latest is a real estate accounting from his estate papers.

Foremost in the series are the letters Hanbury-Williams received from and sent to his wife Frances, his daughters Fanny and Charlotte, and his son-in-law Lord Essex. For all four, both sides of the correspondence are present, but the two sides were not interfiled; letters from each person to Hanbury-Williams precede folders of letters he sent them. Two-way correspondence is also here for two of his younger brothers, George and John; there are a greater number of incoming letters from his older brother Capel. Also of interest are folders of material filed with the letters from Elizabeth Mary Russell Capell, Lady Essex, regarding the negotiations for the marriage of her son William to Fanny Hanbury-Williams in 1754. Additional letters to and from most of the family members in this subseries also appear in Series IV, Capell, Coningsby, and Hanbury Family Papers; none of that material is addressed to or received from Charles Hanbury-Williams.

The subseries Personal Papers includes letters from his physicians John Oldfield and John Truesdale, and appeals from men regarding the death of Jeffrey French and the estates of Hanbury-Williams's maternal grandfather Richard Jones, Lord Ranelagh (1638-1712) of Ireland. Various financial and legal documents reveal some of Hanbury-Williams's other interests, such a list of seeds received from the American botanists John and William Bartram, a list of the Right Worshipful Company of Merchant Advisors of England, and two manuscript library catalogues. Thomas Philllipps suggested those may have been inventories of Lord Coningsby's book collection at Hampton Court Castle in Herefordshire, though there is no other evidence for that claim. A third list of book titles is tipped in at the front of a volume of letters and reports received from foreign envoys in 1752 (Hanbury-Williams volume 18, Phillipps volume 10889 (Box 11).

The subseries Literary Works holds writings by or attributed to Hanbury-Williams as well as works by others such as Lady Mary Wortley Montagu; that piece and some of the other writings may have formerly been owned by his father-in-law Lord Coningsby..

Series III is organized into four subseries: Correspondence with Family Members, Personal Papers, Literary Works, and Estate Papers.

Correspondence with Family Members Organized alphabetically. 1732-1759

Essex, Frances ("Fanny") Hanbury-Williams Capel, 1735-1759

The eldest daughter of Charles and Frances Hanbury-Williams, Fanny was born on March 4, 1735, and married William Capel, Lord Essex, in August 1754. She gave birth to three children, two of whom lived to their majority; she died on July 19, 1759, likely of diptheria. Fanny had a very close relationship with her father, who died three months later, not knowing that she had passed before him.

Fanny Hanbury-Williams Essex's correspondence with her father spans sixteen years, and their letters comprise the largest correspondence group in the papers. Topics covered include innoculation, family activities, news, and travel, social events, and fashion; her letter of February 20, 1755, encloses a list of Dresden porcelain tableware. Letters to her father in the earlier years are often sent by both Fanny and Charlotte writing into the same letter, and letters to Fanny in those same years are addressed to both daughters. Additional letters from and about Fanny are in Box 43, folders 1-3, with material regarding her marriage negotiations.

# Series IV: Capell, Coningsby, and Hanbury Family Papers, 1584-1808

1.67 linear feet (7 boxes)

The series holds a collection third-party letters and documents that were received or sent by members of Charles Hanbury-Williams's family and his extended family through the 1754 marriage of his daughter Fanny to William Anne Holles Capel, Lord Essex. While he may be discussed in some of the letters, particularly those of Fanny to her uncle George Hanbury, no letters in the series were written to or by Charles Hanbury-Williams. This series also contains the earliest and latest items in the collection, both predating and postdating Hanbury-Williams's life; they are found in the papers of his father-in-law, Sir Thomas Coningsby and in the Hanbury Family Papers.

The first subseries, Capell and Essex Family Papers, holds correspondence files for Frances ("Fanny") Hanbury-Williams Capel and her husband William, Lord Essex, as well as his mother and sisters, who received letters from each other and friends. The subseries mostly holds single items, with the exception of the more than twenty letters from Albinia Townshend Brodrick, an Essex cousin-by-marriage who writes to sisters Anne and Diana Capell. Her lengthy letters cover many topics of London society, relationships, travel, and events. Also filed here is a single letter from Fanny Capel to her sister Charlotte Hanbury-Williams Walsingham. Note that Lord Essex's parents and sisters spelled their surname Capell.

The second subseries holds material related to/formerly owned by Thomas Coningsby (1656-1729), the father of Hanbury-Williams's wife Frances. Lord Coningsby's seat was Hampton Court Castle in Herefordshire, where he owned collections of books and historical records from the area that may be represented in one or both of the manuscript library inventories in Hanbury-Williams's Personal Papers in Series III (Box 45).

The third subseries is prominent in holding the correspondence of Hanbury-Williams's wife Frances, and his brothers, cousins, and nephews, in particular his brothers George and Capel Hanbury. George Hanbury's files contain two folders of letters to him from his niece Fanny Capel.

The letters in this series were in the mix of papers coming from the Hanbury-Williams properties in Wales and, as with the rest of the collection, had been bound into volumes with unrelated material; the volumes were taken apart in the 1990s. Biographical notes can also be found in the preceding series. Some of the correspondence here has to do with Charles Hanbury-Williams's estate; other related documents can be found at the end of Series III.

Thomas Coningsby (1656-1729), the father of Lady Frances Hanbury-Williams and father-in-law to Charles Hanbury-Williams, was a prominent Whig politician in the reigns of William and Mary, Queen Anne, and George I. Lord Coningsby entered the House of Commons as member for Leominster, Herefordshire, in 1679 and remained until the election of 1710. In 1698 he married as his second wife Lady Frances Jones (1674–1715), the youngest daughter of Richard Jones, Earl of Ranelagh, an Irish peer and paymaster-general of the forces.

### Correspondence

The correspondence filed here is both to and from Coningsby. It came from three formerly bound volumes, 40, 72, and 80, and was merged when the papers were processed in 2023. Many of the letters use numbers to represent people discussed within the text.

"A Project for service in Ulster 1595" by Ralph Lane

1595

Sir Ralph Lane (1532-1603) was an English explorer who was governor of the unsuccessful Roanoke Colony in Virginia (now Dare County, North Carolina) from 1585 to 1586; he later helped to colonize Ireland.

A seven-page tract and proposal addressed to Queen Elizabeth I, that outlines an early plan for the Plantation of Ulster. A transcription prepared by David Brown, Department of History, Trinity College Dublin, is available in the folder.

Another treatise with the same title by Sir Ralph Lane survives in The National Archives (UK) but it is ascribed a later date (1598): TNA SP 63/202/(4), no. 46.

"The Parliament of Ireland Ani 1634"

The Irish Parliament under King Charles I was opened on July 14, 1634, at Dublin Castle, by Lord Deputy Thomas Wentworth.

The booklet contains speeches by Lord Deputy Thomas Wentworth (1593-1641) and Nathaniel Catelyn (1580-1637). It begins with a passage headed "Carolus Rex: Instructions to be observed by our right trustie and welbeloved Cozin and Counceller Thomas Lord Vicount Wentworth Deputy Generall of our Realme of Ireland by our Councell there & by ye Deputy or other thiese Gouernor or Gouernors & Councell there which hereafter for the tyme shall be and by all other our officers and Mynisters whom it may severally & respectively Concerne." The passage sets out Wentworth's legislative programme for the 1634 parliament in 51 articles with the names of all 34 Privy Councillors listed at the end.

Thomas Wentworth's speech to the Irish Parliament at the opening of the session: "I shall crave leave with your good favour to take you to witnesse as of the greatest honour so of the greatest burthen I ever Sustained being instructed at this tyme in this high Courte to Communicate with you the Councell and the purposes of a wise and mighty kinge." The procedure is similar to that continued to this day by the King's Speech at the opening of the parliament of the United Kingdom. The purpose of the speech is to introduce the forgoing programme of legislation to parliament. (8 pages)

The Speaker's Speech 14th of July 1634 is a formal reply to Lord Deputy Wentworth's address delivered by the Speaker of the Irish House of Commons, Nathaniel Catlyn. (2 pages) undated
