Video Verité/ Alan and Susan Raymond

Video Verité is a film production company owned and operated by Alan and Susan Raymond. Together, the Raymonds have produced over 20 documentary films focusing on social issues of the past five decades. The Raymonds are award winning producers/directors and have won a Pioneer Award from The International Documentary Association, an Academy Award for Best Feature Documentary, 11 Emmy Awards, and were selected as Emmy Legends in 2011 for their work.

Alan Raymond (1943 -) graduated from New York University in 1965 with a Bachelor of Arts in Film Studies. While a film student, he worked as an assistant film editor for Drew Associates from 1965-1967. He moved to Chicago to work for The Film Group, a small production company, where he met Susan.

Susan Raymond nee Cullinan (1945 -) graduated from Depaul University in 1967 with a Bachelor of Arts in Sociology/Anthropology. To finance her education, she worked as a paralegal at a large law firm and later at a Daughters of Charity settlement house. She met Alan while he worked at The Film Group where her brother-in-law, Howard Alk, worked.

Alan and Susan moved to New York City together, got married, and began working in the film production industry. The first project they both worked on was *A Private Decision: The 1968 Presidential Election* where Susan worked as a grip and then did sound, and Alan worked photography and production.

Early in their careers, the Raymonds worked for the New York PBS station WNET/13, Quest productions with Bill Jersey, and N.E.T. Playhouse with The Second City. They met Craig Gilbert, the future producer of *An American Family* (1973), working on the film, *The Triumph of Christy Brown*. Afterwards, Gilbert approached Alan and Susan to work film and sound for a project that eventually became *An American Family*. The Raymonds spent seven months in Santa Barbara filming the Loud family. They had major control of daily filming for the series and developed their cinema verité filming style.

Following the success and acclaim of *An American Family*, Alan and Susan Raymond formed Video Verité and began to produce their own documentary films. Their next project, *Police Tapes* (1977), saw them using low-light equipment to capture the nightly routines of New York City police officers on their patrols in the Bronx. The film won several awards including an Emmy Awards for Directing and Photography and Editing, an Alfred I. DuPont Award for Excellence in Journalism, and a George Foster Peabody Award.

The Raymonds went on to produce more documentary films based on social issues both domestic and international, such as the American incarceration system, inner-city education, music history, mental illness, and the effects of armed conflicts and war. They became well known for investing large amounts of time with their subjects to produce deeper narratives on screen. The Raymonds' documentaries include *To Die for Ireland* (1980), *Doing Time: Life Inside the Big House* (1990), *I Am A Promise: The Children of Stanton Elementary School* (1994), *Children In War* (2000), and *How Do You Spell Murder* (2003).

Scope and Contents

The Video Verité papers (1895-2022) include correspondence, production notes, film logs, transcripts, contracts, budgets, notebooks, research, photographs, negatives, awards, and press created by or relating to the film production company, Video Verite, and its owners, Alan and Susan Raymond.

An American Family (1973)

1971-2011

An American Family (1973) chronicles the daily life of the Louds -- a white, uppermiddle class family in Santa Barbara, California. This television documentary series is known as the birth of reality television. In twelve one-hour unscripted episodes, the show captures the separation and divorce of the parents, Bill and Pat Loud. It also documents the daily lives of their five children. The eldest, Lance Loud, was the first non-fictional openly gay person to recur on a television program. The Raymonds produced three additional projects featuring the Louds: American Family Revisted (1983), Lance Loud!: A Death in the American Family (2003), and An American Family Anniversary Edition (2011).

The Police Tapes (1977)

1975-2016

The Police Tapes (1977) documents the daily life of the 44th police precinct in the South Bronx during 1976. Using a small Sony Portapak black and white video camera and deck, Alan and Susan Raymond capture the dangers and frustrations of the officers. The documentary was a project at the TV Lab at the New York PBS station, WNET/13. The original 90-minute version only aired locally. The film received a Peabody Award, a Columbia School of Journalism DuPont Award, and a local New York Area Emmy Award for Outstanding Documentary. ABC News approached the Raymonds to air a shortened version for ABC News Closeup, which was the first time a network news organization broadcast an independently produced documentary. The Closeup version won a national Emmy Award for Outstanding Documentary and Editing. The Police Tapes is in the permanent collection of the Museum of Modern Art and the Bibliotheque Nationale.

Bad Boys (1978) 1977–2009

Bad Boys (1978) is a two-hour documentary about the juvenile incarceration system and how American society treats those who enter the system. Alan and Susan Raymond focused on three public institutions in New York State: Bryant High School in Long Island City, Spofford Juvenile Center in New York City, and Brookwood Secure Center for Youth in Claverack, New York. While at Brookwood, the Raymonds interviewed 15-year-old Willie Bosket Jr., who upon release would commit a double homicide. Bosket's case directly led to the creation of New York's Juvenile Offender Act which allowed minors to be tried as adults. Bad Boys shares the same film style as The Police Tapes, both were filmed using a Sony Portapak camera and deck. After airing on PBS, the Raymonds were approached by CBS to adapt the documentary into a dramatic movie, but the project was never produced.

To Die for Ireland (1980)

1971-1984

To Die for Ireland (1980) is a one-hour documentary made for ABC News Closeup. After The Police Tapes (1977) was broadcast on ABC, Alan and Susan Raymond became producer-directors for the documentary unit at ABC News. This film captures the relationship between the British Army and the Provisional IRA at the height of the Troubles in Northern Ireland. To Die for Ireland received a News and Documentary Emmy Award for Best Cinematography and was nominated for an Emmy Award for Directing and Outstanding Documentary.
