### **Biographical / Historical**

Gary Franks (1953-) is an American politician who represented Connecticut's 5th district in the United States House of Representatives from 1991 to 1997. Franks was the first African American elected to Congress from Connecticut and the first modern Black conservative elected to the House of Representatives. He was born in Waterbury, Connecticut and received a B.A. in sociology from Yale University in 1975. After an unsuccessful Senate run in 1998, Franks retired from politics. He became a consultant, founding the firms Franks and Genua Associates and Gary Alvin Associates. He has also taught at Georgetown University, Hampton University, and the University of Virginia.

### Scope and Contents

The collection documents the professional and personal life of Congressman Gary Franks. It includes diaries, notebooks, correspondence, reports, press materials, research materials, and writings largely focused on his political career, particularly welfare reform and elections. A significant portion of the professional papers stem from Franks's work as chair of the Welfare Reform Task Force. Records relating to elections include press releases, correspondence, and voter surveys. Also present are a small quantity of papers related to his consultant career, personal papers, and 1 DVD.

Organized into four series: I. Notebooks and diaries, circa 1992-2022. II. Professional papers, 1990-2017. III. Writings, circa 1996-2002. IV. Personal papers, circa 1993-2018.
