## **Processing Information**

This collection received a basic level of processing in 2014, including rehousing and in some instances minimal organization. Various acquisitions associated with the collection have not been merged and organized as a whole. Each acquisition is described separately in the contents list below, identified by a unique call number and titled according to month and year of acquisition.

The finding aid for this collection is compiled from individual preliminary lists for each acquisition that were created at or around the time of receipt by the library. The preliminary lists were migrated to comply with current archival descriptive standards and merged into a single file in 2007-2008. As part of the migration, modifications were made to the formatting of individual lists; however, the content of the lists was neither modified nor verified.

As a rule, descriptive information found in the Collection Contents section is drawn in large part from information supplied with the collection and from an initial survey of the contents. Folder titles appearing in the contents list below are often based on those provided by the creator or previous custodian. Titles have not been verified against the contents of the folders in all cases. Otherwise, folder titles are supplied by staff during initial processing.

This finding aid may be updated periodically to account for new acquisitions to the collection and/or revisions in arrangement and description.

## Biographical/Historical note

Sheri Martinelli (1918-1996), artist and poet, was born in Philadelphia and studied ceramics at the Philadelphia School of Industrial Arts. Martinelli later expanded her artistic repertoire to include abstract painting and engraving. She became an associate of Anais Nin and William Gaddis in 1945 and met Ezra Pound in 1951 or 1952 while he was incarcerated at St. Elizabeth's Hospital in Washington, D. C. They maintained a relationship until 1956, and she provided him with inspiration for his work, including the Cantos, while he provided her with instruction in painting; he published a small booklet compilation of her work, La Martinelli, in 1956. She relocated to San Francisco in the late 1950s and began publishing the Anagogic & Paideumic Review, a literary periodical that published primarily Beat poetry, as well as poems by Charles Bukowski. Martinelli relocated to Virginia in 1984 and spent the rest of her life organizing the Pound-related papers in her possession.

## **Scope and Contents**
