# Biographical / Historical

David Hunter Miller (1875-1954): lawyer; admitted to New York Bar, 1911; special assistant in the State Department, 1917; served on the Inquiry under Col. House, 1917-1918, and at the Peace Conference, 1919; active in League of Nations; editor of the Treaties, State Department, 1929; author of numerous books on history, international law, etc.

# **Scope and Contents**

The Miller & Auchincloss Papers consist of two linear feet of correspondence and memoranda related to the work of law partners David Hunter Miller (1875-1954) and Gordon Auchincloss (1886-1943) as special representatives of the State Department in New York City between March 1917 and August 1918. The appointment went first to Auchincloss, but Miller took over the position shortly after 24 May 1917, when Auchincloss became assistant to the Counselor in the State Department. Miller served in various diplomatic capacities in Paris and London between October 1918 and June 1919, and then continued as representative of the State Department until he resigned the following October.

The duty of the special representative was to gather information at government request about activities with roots in the United States that might be intended to benefit Germany and her allies. Most of the inquiries had to do with transactions between American banks and those in neutral countries in Europe and South America on behalf of their respective clients. These transactions came to the attention of the government mainly through censorship of cables. There were also inquiries about shipments to neutral countries, enemy aliens in the United States, and representatives of American businesses abroad. The government officials with whom Auchincloss and Miller most often corresponded mere Leland Harrison (State Department), Frank E. Carstarphen (Office of the U.S. Attorney for the Southern District of New York), Arthur Woods (New York City Police Commissioner), Dudley Field Malone (Collector of the Port of New York), A.B. Hoff (Naval Communication Service, Office of the Cable Censor), and William J. Flynn (Secret Service). Most of the other correspondents were lawyers or officers of banks and businesses.

The diaries of Auchincloss (1917 Mar-May) and Miller (1917 May-Jun) as special representatives of the State Department are part of the Gordon Auchincloss Papers, Manuscript Group No. 580.

# **Collection Contents Inventory, 1917-1918**

The arrangement is alphabetical. Most papers are filed under the name of a person or company under investigation, but since most matters involved several parties, the choice of file headings was necessarily somewhat arbitrary. Papers about banking transactions are usually filed under the name of the American bank that attempted to cable the transfer, and papers about German-connected businesses are filed under the name of the firm or one of its representatives. Correspondence is usually filed under the name of the correspondent (usually a government. official) only when it is not related to any particular investigation, but Leland Harrison is an important exception to this generalization. There are also a few topical files: "Gold exports," "Mexico," "South America," "Trading with the enemy."
