## **Biographical / Historical**

Stephen Herbert Hymer was born in Montreal, Quebec, Canada in 1934. He received a B.A. from McGill University in 1955 and a Ph.D. from MIT in 1960. Hymer was an assistant professor at MIT from 1962-1963, an assistant professor of economics at Yale University from 1963-1970, and a professor of economics at the New School for Social Research from 1970-1974. In addition to his work on the multinational corporation, Hymer was interested in economic development, especially in the context of Africa. He died in 1974.
