SUMMARY: The papers consist of the research files of Ulrich Bonnell Phillips, an author and history professor. The papers include Phillips's notes and transcripts of historical source materials and the collected papers of several southern families from 1712-1933. The collected papers include correspondence, account books, business records, farm and plantation records, diaries, photographs, and other papers which focus primarily on the years 1790-1865, and the Shenandoah Valley region of Virginia and the Piedmont region of Georgia. Phillips's own papers in the collection include a small amount of correspondence, lecture notes, typescript versions of published essays and reviews, transcripts of materials from various sources, his research notes arranged by topic, and related printed matter.

Biographical / Historical

Ulrich Bonnell Phillips was born in La Grange, Louisiana, on November 4, 1887. He taught history at several universities, including Yale University (1929-1934). He specialized in southern history, collected primary source material, and published extensively on the subject. Phillips died in New Haven, Connecticut, on January 21, 1934.

Scope and Contents

The papers consist of the research files of Ulrich Bonnell Phillips, an author and history professor. The papers include Phillips's notes and transcripts of historical source materials and the collected papers of several southern families from 1712-1933. The collected papers include correspondence, account books, business records, farm and plantation records, diaries, photographs, and other papers which focus primarily on the years 1790-1865, and the Shenandoah Valley region of Virginia and the Piedmont region of Georgia. Phillips's own papers in the collection include a small amount of correspondence, lecture notes, typescript versions of published essays and reviews, transcripts of materials from various sources, his research notes arranged by topic, and related printed matter.

This series contains the letters of several individuals and families including: Thomas and Lizzie Armentrout, merchant-farmers in Virginia (bulk dates 1865-92); the Douglass family of Virginia and Missouri (1808-49); Henry St. George Harris, a planter from Virginia (1846-66); and William Letcher Mitchell, chief engineer of the Western and Atlantic Railroad in Georgia (1830-82). Letters to and from several other individuals who lived in the southern United States in the nineteenth century are also included in this series.

Series II: Records, bonds, and accounts, 1753-1882

The series consists of promissory notes, bonds of indebtedness, court records, and accounting volumes. Material of George Rochfort, a merchant from Athens, Georgia (1795-1817) and John Robinson, a whiskey and cloth merchant from Lexington, Virginia (1805-1826) are included in this series. Other items also arranged here include a diary (1857-58) of Richard M. Venable of Virginia, and business and household accounts of Jesse Scott (1821-36), Richard V. Tiffey (1835-37), Thomas Massie (1748-98), Howell and Mary Ann Lamar Cobb (1840-42), and William Letcher Mitchell (1823-29).

Series VI: Cabell-Hare family, 1792-1825

This series consists of account books, correspondence, and papers documenting the lives of William B. Hare (1760-1818), a physician and landowner, and his descendants. These papers contain information on the economic, social, and political activity in the tidewater region of Virginia, and documentation on tobacco and wheat farming, plantation life, medical practice, slavery, and local merchants. A diary of Philip Rootes (1792 Nov-Dec) is also included in this series.

Series VII: Dorman family, 1821-1881

This series contains correspondence and papers of James Baldwin Dorman (1823-1893), a lawyer, Virginia state legislator, and member of the 1861 Secession Convention. Photostatic copies of papers of James Dorman Davidson, which Phillips obtained from the McCormick Agricultural Library in Chicago, Illinois are also included in this series. Dorman correspondence during the 1840s, and his diary (1841-49) detail his student life at Washington College, and his experiences as a school teacher, traveller, and soldier during the Mexican War. Letters from Dorman's parents, Charles P. and Amanda Elizabeth McCue Dorman, detail family matters.

Series VIII: McDowell Family, 1792-1861

This series consists of correspondence and papers documenting the lives of family members in Virginia, Kentucky, Missouri, and elsewhere. Family members represented in this series include: James McDowell (1770-1835), a farmer with extensive land holdings in Virginia and Kentucky, a prominent figure in the state militia during the War of 1812, and the father-in-law of Thomas Hart Benton, the Missouri senator whose four letters refer to political topics; James McDowell (1795-1851), a student at Yale College who left a two thousand acre plantation in Kentucky given to him by his father in order to enter Virginia politics as a Democrat. Few political papers detail his activity as a state legislator (1830-38), governor (1843-46), and Congressman (1846-51). Other family members represented to lesser degrees in this series include: James McDowell, a Kentucky physician, and Samuel McDowell and his descendents.

Series IX: Moore family, 1794-1865

This series consists of correspondence and papers of Andrew Moore (1752-1821), a representative (1789-99) and senator (1800-09) from Virginia, and Samuel McDowell Moore (1796-1876), a lawyer educated at Washington College who served in the Virginia General Assembly (1825-47), and as a congressman (1833-35). He also campaigned unsuccessfully for governor, and attended the Constitutional Convention of 1829-1830 and the Secession Convention of 1861. Andrew Moore's letters comment on the Embargo and Non-intercourse incidents during the years 1807-1812. Samuel McDowell Moore's letters include references to political and family matters.

Series X: Newton-Steele family, 1803-1864

This series consists of the papers of John Newton and Robert Steele, brothers-in-law and tradesmen in Virginia. Newton was a hatter, farmer, and justice of the peace, and his papers include several items relating to his official duties as magistrate. Steele was a dry goods merchant whose financial difficulties led him to emigrate to Missouri. His death in the 1840s and the subsequent plight of his family is detailed in letters written by Steele's widow to Newton.

Series XI: Reid family, 1758-1867

This series consists of correspondence, account books, land and legal records, and related papers of several family members in Virginia. Andrew Reid (1751-1837) was a farmer, clerk of the county court, and clerk of the circuit court. His papers include court records, bonds, official documents, and extensive correspondence relating to agricultural matters. Another Andrew Reid (fl. 1805-11) appears as a correspondent in 1805 and, in letters dating through 1811, Reid discusses experiences as a Virginia legislator and as a young lawyer. His extensive correspondence with Samuel McDowell Reid and former Washington College classmates includes mention of family and political affairs, such as the Burr Conspiracy. Samuel McDowell Reid, who succeeded his father Andrew as clerk of the county and superior courts also served in the Virginia legislature during the Civil War, ran a large legal practice, supervised four major estates, managed family lands in the west, and served as a trustee for Washington College. Correspondence documents his activity as a lawyer, businessman, legislator, and plantation manager. Reid frequently dealt with the issue of slavery in his business dealings, and it is a common topic in his letters.

Series XII: Thomas family, 1849-1888

This series consists of the correspondence and papers of Thomas W. Thomas, a lawyer in Elberton, Georgia, and active in Democratic politics until 1850, when he joined with Howell Cobb, Robert Toombs, and Alexander H. Stephens to form the Constitutional Union Party of Georgia. He later became a judge in the state superior court and a colonel in the Confederate army. Correspondence details Thomas's legal and financial affairs, and includes letters from many minor Georgia political figures and other family members.

Series XIII: Willson family, 1806-1869

This series consists of correspondence, financial records, and papers relating to the land holdings and farming activities of Thomas Willson, a Virginia and Indiana farmer. Correspondence with his Indiana agents: Thomas McClure, Arthur Compton, and John Buntain document more than thirty years of agricultural activity. Willson's letters with his brother William B., an Ohio physician, also focus on farming matters.

The remaining papers document the lives of the children and grandchildren of James S. Willson, a brother of Thomas and William B. Willson. Elizabeth Ann Willson, an unmarried daughter, and two sons, William Finley Willson, another Ohio physician, and Thomas Newton Willson, a schoolteacher, discuss abolitionist views, pro-slavery sentiments, and family, economic, and political matters with each other and their father James.

Series XIV: Walker family, 1818-1847

This series consists of correspondence among members of the Walker family in Virginia and relatives in the South and West. Joseph and John B. Walker comment on Missouri land speculations, Hugh and James C. Walker detail life in Tennessee, William and Sam Walker detail life at Princeton, and Henry Brown writes of his preaching experiences in the Kanawha Valley.

This series consists of Ulrich B. Phillips' research notes relating to southern history. Phillips transcribed historical sources in academic institutions, libraries, and private sources. Selected portions of these transcripts appeared in such published works as *The Correspondence of Robert Toombs, Alexander H. Stephens, and Howell Cobb*. Most of the material in this series is undated; specific dates are noted at the file level below only when known.

This accession contains photographs, glass negatives, stereoscopic photographs, and a small amount of printed ephemera documenting the southeastern United States, especially South Carolina and Louisiana, during the first part of the twentieth century. Subjects depicted included blacks, both casually and at work; city and rural life; and work activity in cotton and sugar cane fields. Photographs also document buildings, including cabins, slave quarters, plantation homes, farms, and cities. Most of the photographs are undated and are circa 1900-circa 1930 unless more specific dates are noted at the file level below. Some of the photographs are annotated with plate numbers and appear to have been used as illustrations in Phillips's books.
