#### Biographical / Historical

Selden Warner was a son of Jonathan Warner, of Hadlyme Parish, in Lyme, Connecticut, and grandson of Andrew Warner. His mother was Elizabeth, daughter of Joseph Selden, Junior, of Haddam.

He became a physician in Hadlyme, and married in 1788 his second cousin Dorothy, youngest daughter of Colonel Samuel and Elizabeth (Ely) Selden, of Lyme, who died in 1825, at the age of 57.

He died in Hadlyme, from paralysis, on March 1, 1843, aged 82 years. His children were seven sons and two daughters. One son was graduated at Yale in 1817, who followed his father's profession; and a granddaughter married Chief Justice Morrison R. Waite (Yale 1837).

#### **Scope and Contents**

Correspondence and other papers (1798-1839) of Selden Warner and various members of his family make up the Selden Warner Papers. Both family correspondence and a few business letters, one written by Jeremiah Day, are included, as are legal and financial papers such as indentures and documents relating to the estates of Elizabeth and Jonathan Warner. Over half of the collection consists of accounts and other papers relating to the shad fishing industry near Lyme, Connecticut, in which Selden Warner and his sons were active.

These papers were given to Yale University by Henry Selden Johnston in 1945.
