Shipping and business records make up the papers of Samuel C. Johnson (1792-1872) of Guilford, Connecticut. The papers, which include bills, orders, receipts, invoices, inventories, and other financial and legal papers, detail goods and prices for shipments of merchandise on the sloop *Clarissa* sailing out of Naugatuck and Guilford under Captain Isaac Meigs, as well as other business transactions carried on by Johnson. The papers are arranged in chronological order.
