Biographical / Historical

Frank Logue was born in Philadelphia on August 18, 1924. He attended Yale University, enlisted in the military after Pearl Harbor, and served as an infantry soldier in France. He returned to Yale Law School in 1948. Logue entered politics in 1953 and held a number of positions, serving on the New Haven Board of Aldermen from 1972-1975. He was mayor of New Haven from 1976 to 1979. Logue died in Hamden, Connecticut, on December 31, 2010.

Scope and Contents

The papers consists of subject files, which include correspondence, maintained by Logue and his staff during his tenure as mayor of New Haven, Connecticut.

General

Boxes 7-12, 19-24, and 31-36 were flood damaged.
