# **Biographical / Historical**

Edward Roy Becker was born on May 4, 1933 in Philadelphia, Pennsylvania. He attended the University of Pennsylvania for his B.A., graduating in 1954. He then received his LL. B. from Yale University in 1957. After graduation, he went into a private law practice, Becker and Becker. He worked in the practice for 13 years. In 1970, President Richard M. Nixon appointed Becker to the United States District Court of Eastern Pennsylvania. In 1982, President Ronald Reagan appointed Becker to the United States Court of Appeals of the Third Circuit. He went on to become the chief judge in 1998 and held that position until May 4, 2003. On that date (his 70th birthday), he was mandatorily assigned senior status. Becker continued to serve on the court until his death from prostate cancer on May 19, 2006. During his time as a judge, he was known to be an expert on antitrust law and use of expert evidence in trials. He also worked on many notable cases, including *Matsushita Electric Industrial Co., Ltd. v. Zenith Radio Corp., Artway v. The Attorney General of the State of New Jersey* and *E.B. v. Verniero, Karcher v. May, United States et al. v. the American Library Association* and *Amchem Products, Inc. v. Windsor*.

# **Scope and Contents**

The collection comprises the papers of Judge Edward R. Becker, who served both with the United States District Court of Eastern Pennsylvania and the United States Court of Appeals for the Third Circuit. His

papers include correspondence, court memoranda, other court-related documents, speeches, subject files, programs and fliers, and newspaper and journal clippings, mainly related to cases over which he presided. Materials cover from 1943 to 2006, with the bulk from 1972 to 2006.

There are some case materials included in the collection, including papers focusing on *Matsushita Electric Industrial Co., Ltd. v. Zenith Radio Corp.*. Much of the collection is focused on Becker's other judicial activities though, including his work with asbestos legislation, the Judicial Conference of the United States, and Third Circuit task forces on indigent litigants and the death penalty. Also included are plans for the timing of hiring law clerks in the federal courts, Continuing Legal Education (CLE) courses, especially on representing asylum-seekers in the federal courts, and research on legal concepts such as sentencing guidelines, class action lawsuits, and expert evidence in court hearings. There are also materials related to the Senate confirmation hearings for Justice Samuel A. Alito's nomination to the Supreme Court of the United States. Finally, a small but significant part of the collection includes papers related to Becker's different civic activities, including his work creating a Magna Carta exhibition in Philadelphia, Pennsylvania.

# **Collection Contents**

### Series I: Correspondence, 1970-2006

Series I comprises correspondence Becker received, with occasional copies of letters that Becker sent.

Business correspondence mainly contains letters of thanks, related information to publications, and letters from lawyers and other judges relating to programs Becker was involved in as well as Becker's opinions and rulings. There are also several folders that are specifically focused on topics, including his work with the Administrative Office of the United States Courts, letters related to general civic causes, and letters sent only to Becker while he served at the Eastern District of Pennsylvania court and the Third Circuit Court of Appeals. For communications between multiple judges at each of these courts, please refer to the memoranda and other court communications folders located within Series II, Judicial activities. For more focused correspondence related to individual topics, individual professional organizations and individual civic causes, please refer to Series III, Series V, and Series VI respectively.

Personal correspondence includes thank you letters and notes, general letters of news between correspondents, and unofficial communications between different judges and between judges and law clerks. There are also several folders that are focused on specific topics, including congratulatory notes related to specific awards and letters to businesses.

Charles Peruto involving Becker and others for misconduct. Finally, there is a section of photographs that depict court functions and include official court portraits, many of which are undated.
