Processing Information

Collections are processed to a variety of levels, depending on the work necessary to make them usable, their perceived research value, the availability of staff, competing priorities, and whether or not further accruals are expected. The library attempts to provide a basic level of preservation and access for all collections, and does more extensive processing of higher priority collections as time and resources permit.

This collection received a basic level of processing in 2015, including rehousing and minimal organization. The collection was arranged by a previous owner into 14 groups, and where possible, these groups have been maintained and recorded in the finding aid. Previously ungrouped, miscellaneous bills have been added after Group 14. An item-level list apparently created by Charles Eberstadt is present in box 1. This finding aid may be updated periodically to account for new acquisitions to the collection and/or revisions in arrangement and description.
