# **Biographical / Historical**

Robert Palmer Anderson was born on March 27, 1906 in Noank, Connecticut. He was the son of Arthur P. Anderson, a probate judge in Groton, Connecticut, and Jessie P. Ashby Anderson. He lived in Noank until he started high school at the Phillips Academy in Andover, Massachusetts. He was admitted into Yale College and graduated in 1927 with a BA in law. He then attended Yale Law School and graduated in 1929 with a LLB in law. He practiced general law with the firm of Waller, Waller, Avery and Gallup in New London, Connecticut, becoming a partner in 1935. In 1934 he was elected Justice of the Peace in Groton, a position he served into the 1940s. In 1936 he was also appointed a United States Commissioner.

After the United States entered World War II, Anderson was commissioned in the United States Coast Guard Reserve as a Lieutenant on January 21, 1942. He served in New London, Connecticut until January 1943. After attending Officers' School in St. Augustine, Florida, he was sent to North Africa in April 1943 as a part of the Lend-Lease Administration. He then was posted in Bizerte, Tunisia as part of the Navy's 8th Amphibious Force, and in the Mediterranean and the English Channel for Flotilla #4 LCI-Ls from May 1943 to November 1943. He was then assigned to the 11th Amphibious Force that participated in the Normandy Invasion, more commonly known as D-Day, until November 1944. Afterwards, he was posted in Washington D.C. as the Chief of the Rescue Vessel and Station Division of Air Sea Rescue at Coast Guard Headquarters and led the Coast Guard reserve unit in New London, Connecticut until he retired in 1957 due to the separation of powers doctrine. He was awarded the Bronze Star Medal by the United States and the Order of the British Empire by the United Kingdom for his service.

Anderson began his work in politics and the state and federal court system in 1936 when he was appointed Public Defender for New London County. In 1946 he was elected to the Connecticut Senate, representing the 18th district. In 1947, he was appointed State's Attorney for New London County. He also served on the military staff Connecticut governors McConaughy, Shannon, and Lodge. He then resigned these positions when he was sworn in as a judge for the Connecticut Superior Court on August 10, 1953. These were succeeded by appointments to the United States District Court in 1954, where he became chief judge in 1960, and to the United States Court of Appeals, Second Circuit in 1964. He assumed senior status for the latter in 1971, but went back to active duty in 1972 when the Temporary Emergency Court of Appeals was reformed to exercise judicial rule over an energy price stabilization program. Anderson worked until his death on May 2, 1978, filing his final decision the day before.

# **Scope and Contents**

The papers document the professional and personal life of federal judge and Yale University alumnus Robert P. Anderson. # Collection Contents Series I: Personal papers, 1880–2014

This series comprises materials documenting the personal information, early life, and family history of Anderson. Biographical materials cover aspects of his life from childhood to his death and include address books, diaries, obituaries and biographical sketches, passports, and religious texts. Correspondence in this series cover a diverse range of subjects. Much of it is with family and friends, but there is a significant amount that focuses on business and community affairs, such as his law practice, properties, and his work with the Marine Historical Society in Mystic, Connecticut. Materials related to his education cover all levels from primary school to post-secondary, with the bulk of materials related to Yale College and Yale Law School. Yale College materials contain coursework and Yale publications while Yale Law School materials almost entirely consist of handwritten class notes. Materials related to his military service focus on his time in the Coast Guard Reserve during World War II and mainly consists of training materials, orders and post assignments, and activities at his different posts, including New London, Connecticut, Portsmouth, England, and Bizerte, Tunisia. There is also a small number of materials related to honors and military awards received, including the Order of the British Empire from the United Kingdom. Finally, there are personal photographs and scrapbooks, mainly of newspaper articles covering events involving Anderson. Materials are from 1880 to 2014, with the bulk from 1927 to the mid-1960s.

Series I is arranged under six headings: biographical materials, correspondence, education, military service, photographs and scrapbooks, and professional associations. Within headings, materials are arranged alphabetically.

# Series III: Judicial career, 1940–2011

This series comprises materials documenting Anderson's judgeships, both state and federal. Government attorney positions mostly contain materials related to his position as State Attorney for Connecticut, but it also includes files from his tenure as the Public Defender for New London County and serving on the Governor's military staff. Judgeships include his service on the Connecticut Superior Court, the United States District Court, the United States Court of Appeals, Second Circuit, and the Temporary Emergency Court of Appeals. Materials from the Connecticut Superior Court include jury charges, dockets, correspondence and case files. Case files mainly consist of memoranda of decisions. United States District Court files are primarily made up of case files, particularly the New Haven Railroad bankruptcy proceedings, as well as higher profile cases such as Butterworth v. Dempsey and United States v. Silverman. There are also files consisting of law clerk materials, memoranda of decisions, and Judicial Conference files. United States Court of Appeals, Second Circuit materials contain files on various court issues, such as comments on Anderson's rulings and reports on extra-judicial income, as well as a full index of cases heard by Anderson and correspondence. Records related to his service on Temporary Emergency Court of Appeals are limited and include some of his draft opinions. Materials cover from 1940 to 2011, with the bulk of materials from 1940 to 1975.

Series III is arranged under two headings: government attorney positions and judgeships. Within headings, materials are arranged alphabetically.
