Processing Information

Collections are processed to a variety of levels, depending on the work necessary to make them usable, their perceived research value, the availability of staff, competing priorities, and whether or not further accruals are expected. The library attempts to provide a basic level of preservation and access for all collections as they are acquired, and does more extensive processing of higher priority collections as time and resources permit.

This collection received a basic level of processing, including rehousing and minimal organization.

Folder titles appearing in the contents list below are often based on those provided by the creator or previous custodian. Loud family

The Loud family was the subject of the documentary television series *An American Family*, which aired on PBS in 1973 and is often described as the first American reality television show. The show featured parents Pat and Bill Loud and their children Lance, Kevin, Grant, Delilah, and Michelle.

Lance Loud

Lance Loud (1951–2001) was the eldest son of the Loud family, which was the subject of the documentary television series *An American Family*. He was a focal point of the series in part because he announced his homosexuality during the filming of the show. Loud's band, the Mumps, were regular performers in the downtown New York City punk scene in the 1970s. He remained a fixture of the New York and Los Angeles social scenes and worked as a freelance journalist, often working with *Details* magazine.

Scope and Contents
